- (2) Any member of the public is welcome to address the Commissioners Court at its next posted regular meeting. Please indicate whether you are addressing an item on the posted regular agenda or whether providing general public comments. Regardless of the desired method to address the Court, public participation forms will not be accepted prior to the posting of the agenda.
- (3) Public participation forms submitted with written statements that do not wish to address the Court must be submitted by noon (12 p.m.) the day before the regular posted meeting. The forms will be attached to the online posted agenda under the "Public Comments" section of the agenda prior to the meeting for public review with copies provided to the Court members. Written statements will not be read aloud during the Court's session.
- (4) If you are wishing to address the Court at its next posted regular meeting via telephone, you must notify the Court using the public participation form by noon (12 p.m.) on the day before the regular posted meeting in which you wish to speak.
- (5) The County Judge as presiding officer of the Commissioners Court may impose time limits and any procedures deemed necessary for the effective operation of the Court.

Catherine Colquitt, MD, medical director for Tarrant County has been silent. She is paid by the Tarrant County Tax payors \$225, 000 a year. This salary is on top of what she makes in her private practice as infectious disease physician.

Like yourself, she is out of touch or simply has her own agenda. She is continuing to be paid through this scamdemic .

Draconian unconstitutional mandates and public health recommendations are being made that have greatly affected citizens mental, physical, spiritual and economical health.

Dr. Colquitt has not provided any updated education to the public regarding this so called pandemic. There are physicians in this country and around the world that successfully treat patients with SARS COV 2 with outpatient medical regimens. I am demanding a town hall meeting with Dr. Colquitt. The public needs to hear from her. We need to be able to ask her questions and allow her to give us rationale. This has been 9 months, not 2 weeks. Case counts are meaningless. Death statistics does have meaning. There have been no more deaths in the USA or in Tarrant County this year than the past 2 years. As of November 16<sup>th</sup>, 2020, 2, 487,350 deaths in the US. In 2019 theirs were 2,900,689 deaths and in 2018 there were a total of 2,839,205 deaths .

We need to know the names of "your people" , that you get your information from to base your decisions.
